Release and Waiver Form

Further, I understand that the Tigergoode Wrestling Club is owned and operated by Steven W. Goode.

I verify that my child has been checked by a licensed physician with in the last 12 months and is able to participate in a physically demanding activity such as live wrestling. I agree to allow my child to be taken to a local hospital and to be treated by a licensed physician, registered nurse or club trainer if necessary and to assume all cost related to such treatment.

As a condition of enrollment, the following Disclaimer of Liability must be signed and dated by parents or legal guardian.

The Club Member in attending the Tigergoode Wrestling Club Inc. owned by Steven Goode and in using any of the practice facilities used by the Tigergoode Wrestling Club Inc. and employees does so at their own risk. The Fessenden School, Brookline High School, and both of their athletic departments, their employees, the two locations where the wrestling club will operate, Steven Goode, the club's coaching staff or Tigergoode Wrestling Inc. shall not be liable for any damages or injuries sustained by a club member because of his or her participation at the club practice or at club competitions. The wrestling club member and his or her parents or legal guardian assumes full responsibility for any damages or injuries which may occur to a club member at any one of the wrestling clubs sites operated by Steven Goode and so hereby fully and forever exonerate and discharge the wrestling club owned by Steven Goode, his staff, its owner, employees and agents from any and all claims, demands, damages rights of action or causes of action present or future, whether the same be known, anticipated or unanticipated, resulting from or rising out of the wrestling club member participation in any one of the wrestling clubs locations operated or owned by Steven Goode. The club member and his or her parents or legal guardian also realize that the assumption of risk should be an automatic assumption when one participates in the sport of wrestling.
